LAST WILL

I, ARCHIBALD ANDERSON HILL, of 3403 Mt. Bonnell Drive, Austin, Texas, being of sound and disposing mind and memory, do hereby make, publish and declare this to be my Last Will and Testament, thereby revoking any and all other Wills or Codicils thereto heretofore made by me.

FIRST: I direct that all my debts, including expenses of my last illness and funeral and burial expenses, be paid when due or as soon after my death as is practicable. I further direct that all estate, inheritance, succession, legacy or other death taxes levied or assessed upon or with respect to any property required to be included in my gross estate by reason of any state or Federal law now or hereafter in force, shall be paid out of my estate as expenses of administration and as general charges thereon.

SECOND: All the rest, residue and remainder of my property and estate, of every name, kind and nature, real, personal and mixed, community and separate, wherever situated, of which I shall die seized and possessed, and all to which I shall at any time or in any manner be entitled in law and equity, including all contingent, executory, and future interests and all property over which I may have the power of appointment at the time of my death, I give, devise and bequeath to my and my dear deceased wife's friend MURIEL LYDIA WRIGHT, residing at 1211 West 22-1/2 Street, Austin, Texas 78705, but if she does not survive me, this gift shall lapse.

THIRD: If our friend MURIEL LYDIA WRIGHT does not survive me, all the remainder of my Estate, including any preceding gift which may have lapsed, herein referred to as "my residuary estate," I give to LINGUISTIC SOCIETY OF AMERICA, a corporation

duly incorporated and existing under the laws of the District of Columbia, with offices at 1325 18th Street, N.W., Washington, D.C. 20036, or its successor, for its program for the future of linguistics.

FOURTH: I hereby appoint my friend and attorney ALVIN J. BURNETT, of Forest Hills, New York, Independent Executor of my Estate. If ALVIN J. BURNETT should, for any reason, fail or cease to act as Executor, I appoint MURIEL LYDIA WRIGHT substitute or successor Independent Executor of my estate.

All references herein to Executor shall refer to the Executor or Executors (whether Independent or otherwise) then acting hereunder.

Each Executor shall be entitled to reimbursement for expenses necessarily incurred in the administration of my Estate.

Except for MURIEL LYDIA WRIGHT, each Executor shall be entitled to receive reasonable fees for services actually rendered to my Estate, taking into account the nature of my Estate, the time involved, and services rendered.

No bond or other security shall be required of any Executor hereunder, and I direct that no action shall be had in any court of probate jurisdiction in relation to the settlement of my Estate other than the probating and recording of this Will and the return of an inventory, any required appraisalment and list of claims of my Estate. In addition to having all the powers of Independent Executors under the laws of Texas, my Executor herein shall have the power to retain any property at any time forming a part of my Estate, the power to sell, transfer, lease or encumber all or any part of my Estate, the power to partition any part or all of any interest in my Estate, and to pay or receive such moneys or properties as may

be necessary to equalize differences, the power to make any distribution in any manner whatsoever (including composing shares differently) based on date of distribution value, the right to deal with any person regardless of any relationship or identity of any Executor to or with such person or entity, the right to allocate receipts and disbursements of my Estate between principal and income in any manner, and all of the rights, privileges and powers of trustees under the Texas Trust Code, as amended. This instrument shall always be construed in favor of the validity of any act or omission by or of an Executor, and no Executor shall be liable for any act or omission except in the case of gross negligence, bad faith or fraud. It is my intention that so far as can legally provided, my Executor shall be completely free of all court supervision, including the requirement of any accounting.

FIFTH: For all purposes of this Will, if any beneficiary dies within thirty (30) days after my death, such person shall be presumed to have predeceased me. This presumption shall not affect the appointment of my Executor.

SIXTH: Prior to final distribution of my Estate (which shall not be unreasonably postponed by my Executor), partial distributions may be made to any one or more beneficiaries in the discretion of my Executor. Any distribution may be made subject to any indebtedness or liability of my Estate.

SEVENTH: If any provision of this Will should be held illegal or invalid when applied to any property interest in my estate, such invalidity or illegality shall not affect the remaining provisions, or any other property interests, and each provision of this Will shall exist separately and independently, and shall be applied to property interests, separately and independently, of every other provision, and

this Will shall be construed as if such illegal or invalid provision had never existed.
